### Frequency of BoG Meetings:

- Meetings of the Governing Body will be held at least twice a year.

### Functions of BoG:

- It evolves the Vision, Mission and Objectives of the College and ensures that they are achieved.
- The BoG makes all policy decisions. It guides the institution while fulfilling the objectives.
- Institute scholarships, fellowships, medals, prizes & certificates on the recommendations of the Academic Council.
- It approves new programmes of study leading to degrees and/or diplomas.
- All recruitments of Teaching Faculty/Principals will be made by the Governing body.
- Governing Body/state government as applicable, by the policies lay down by the UGC and State Government from time to time.
- Approves the annual budget of the institution before submission to UGC.
- Performs such other functions and formation of institute committees, as may be necessary and deemed fit for the proper development of the institution.
- It administers the physical resources of the Institute.
- Reviews the performance of the Institute and guides to function effectively to Achieve Excellence in Academics, Research and Industry collaborations.
- Ensures the Regulatory Compliance of all the decisions by the concerned Authorities like the Principal, HoD and other Officers of the Institution in all matters of fundamental concern.
- Ratifies and resolves the minutes of the Academic Council, Board of Studies, Finance Committee and IQAC
- Reviews to apply Accreditations of different regulatory bodies (NBA, NAAC, UGC & ABET etc.)
- Monitors the effective functioning of different non-statutory committees of the institution.
- Encourages and assists in the submission of proposals to different funding agencies.
